Full Description: Sliced Carrots are prepared from clean, sound carrots packed in water with salt and calcium chloride. The product is packed in hermetically sealed containers and sufficiently processed by heat to assure preservation.

Quality Characteristics:

Style	Sliced – carrots which are cut into slices not thicker than $\frac{1}{4}$ ". In 90 percent, by count, the slices that are most uniform in diameter, the diameter of the slice with the greatest diameter is not more than 1 $\frac{1}{2}$ times the diameter of the slice with the smallest diameter.
Quality	Must meet USDA Grade A. Must comply with US Standards for Grades of Canned Carrots, with modifications noted within these specifications.
Color	Shall be bright and typical uniform yellow-orange color. Presence of green units does not more than slightly affect appearance of eating quality of the product.
Maturity	Must be tender but not mushy and possess a fine and even texture, free from stringiness. Units must have a clean cut appearance and show no more than a trace of sloughing in the brine and which does not noticeably affect appearance or eating quality of the product.
Defects	Practically free from defects. Presence of blemished and seriously blemished units does not more than slightly affect the appearance of the product.

Physical Characteristics:

Seneca Foods Corporation produces our products to meet a target specification at the time of production. Due to the nature of our commodity products, there are factors such as product maturity, variety, moisture level, and the growing conditions of each particular field which may cause a deviation from the target specification as the product cycles through the shelf life.
